Aims: The Study Group aims to facilitate interchange between all those interested in the broad area of families, intimacies and personal relationships.

- To provide a forum to bring together the diversity of studies of families, households and relationships of members working across academic disciplines.
- To promote dialogue between those who focus on the sociology of families, intimacies and
 relationship and specialists in gender, sexuality and relationships research, taking in the broad
 range of possible substantive and theoretical concerns of contemporary sociology and forging
 new connections.
- To encourage links between established and early career researchers regionally, nationally and internationally, providing an opportunity for networking and the development of collaborative research across the fields of study.
- To interrogate the key concepts and theoretical frameworks which are deployed in sociological analyses of families and relationships.
- To complement the work of university based research centres by providing a national network and hub for discussion.

Review of the year

Membership of the Families and Relationships Study group has risen steadily and we now have 360 members (from 19 countries). The vibrancy and high level of interest in this broad area is further demonstrated by the number of paper submissions received for the BSA Annual Conference, Families, Relationships, Lifecourse Stream and high profile plenary speakers.

Current convenors for the group have been in post from April 2014. However, Kathryn Almack will be stepping down as convenor in April 2017 and we will be looking to appoint a new convenor to carry on alongside Jo Woodiwiss. As convenors we ensure that the email list continues to provide a dynamic channel of communication, enabling members to hear about up and coming events, job vacancies, studentships and fellowships, and new books published in this field.

The membership of this group, as measured by the email list, has expanded this year and the Study Group continues to go from strength to strength. In addition to publicising research, events and publications that might be of interest to members, twice a year we also invite members to send in updates which we compile to send out a bulletin of activities and other news to all members. We regularly ensure contributions from members' activities are represented in the newsletter Network.
