**Number of members**: We currently have 93 people registered with the Jiscmail list, 14 of these are BSA Members and 79 are Non BSA Members

**Income**: On the 1<sup>st</sup> January 2023 we started with a study group account balance of £1,666.92 No costs have been incurred in the last year.

- To support the aims of the BSA

## **Review of the year:**

- We regularly maintain the study group Twitter / X account which has over 1,400 followers. This helps to maintain the profile of the study group, and links with other BSA study groups.
- We also have an active Jiscmail list and circulate relevant messages when received.
- Our focus this year has been planning for a large in-person event in Summer 2024 on the topic of 'Drinking spaces: Past, Present and Future'. The event will be a collaboration with the Drinking Studies Network 'drinking spaces' cluster. The planning of the event is being led by Clare Markham supported by Kat Jackson and Samantha Wilkinson. This event will be held in Nottingham, which we feel will be accessible to potential attendees from across the UK.
- We also actively link with and engage with other relevant organisations. Claire
  Markham and Sam Wilkinson hold roles in the International Drinking Studies
  Network. Sam Wilkinson is a Co-Convenor of the 'Identities and Diversity' Cluster.
  Kat Jackson is actively involved in and has published with a BSA group concerned
  with integrating sociological concepts and theories into Public Health.
